





## REACH COMPLIANCE NOTIFICATION Article 33 of the Regulation 1907/2006/EC

Pursuant to Article 33(1) of the European Union Registration, Evaluation, Authorization of Chemicals (REACH) *Regulation 1907/2006/EC*, Tecnikabel S.p.A., on behalf of itself and operating subsidiaries, has an obligation to communicate to professional customers information about certain substances contained in our products that are manufactured in or imported into the Member States.

The European Chemicals Agency (EChA) has officially published the Candidate list of substances of very high concern (SVHC) that meet the above criteria. Last known materials inclusion update is dated **July 16, 2019** and can be viewed via the following web link: <u>https://echa.europa.eu/de/candidate-list-table</u>.

In response to our above obligations, as part of this SVHC identification process we have:

- reviewed internal/publicly available engineering data in relation to the presence of **SVHC**s in our products or any of their component parts;
- reviewed available safety data sheets for all our input materials;
- communicated with our suppliers to exclude/confirm the presence of SVHCs in any component parts of our products;

As a result of this process, we confirm that our products do not contain any SVHCs included on the Candidate List in concentrations above 0.1 % (w/w).

Our cables do not contain the 69 substances listed in Reach Annex XVII.

Since we are supplying only finished electrical cables (articles), according to the current legislation we are not required to provide our products accompanied by a Material Safety Data Sheet.



## **RoHS 2** directive 2011/65/EU - **RoHS 3** directive 2015/863/EU MATERIAL DECLARATION CERTIFICATE

According to the provisions of the European *RoHS-Directive 2011/65/UE* (Restriction of Hazardous Substances) on the restriction of the use of certain hazardous substances, the content of such dangerous substances electrical and electronic equipment must not exceed the limits determined in the a.m. Directive.

We confirm that all our cables do not contain the ten restricted use substances. This Declaration is based on our analysis, vendor supplied analysis or material certifications, and/or lab test results of the component raw materials used in the manufacture of our cables.

As from the effective date of Jan. 3, 2013, we hereby declare that the application of the CE marking of the products listed in the attachments confirm Compliance under Article 16 of Directive 2011/65/EU. On 4 June 2015, the EU commission has published a new directive, <u>EU RoHS 3 (Directive 2015/863/EU)</u>, to amend Annex II to <u>EU RoHS 2</u> (<u>Directive 2011/65/EU</u>) to add the other 4 phthalates nor the other six restricted substances. No exemption is needed because our cables do not contain any of these restricted substances.

It is our intention to meet the requirements set by REACH and RoHS directives, and we shall continue to inform you, in the framework of our business relations, of any changes to the above.
